Excelsior Academic Software License Agreement

This License Agreement ("Agreement") is a legal agreement between:

(single Academic Institution legal entity, hereinafter "You")

("Excelsior")

for the Excelsior software product identified above, which includes computer software, electronic documentation, and the associated printed materials ("Software"). By installing, copying or otherwise using the Software, you agree to be bound by the terms of this Agreement. If you do not agree to the terms of this Agreement, you may not install or use the Software.

This Academic License Agreement is only offered by Excelsior to a limited class of Academic Institutions, which are defined in the sole and exclusive final determination of Excelsior as degree-granting accredited colleges and universities together with their affiliated graduate schools and affiliated non-commercial research institutions, operating under one Administrative/Admissions Department. Excelsior reserves the right to decide on a case-by-case basis whether or not the particular institution qualifies for this License Agreement.

This Academic License Agreement authorizes use of the Software only for teaching and non-commercial research activity. A research activity is considered non-commercial only if its results are not intended primarily for the benefit of a third party, are made available to anyone without restriction on use, copying, and further distribution, and are furnished at no more than the cost of reproduction and shipping.

This Academic License Agreement is not valid until an authorized representative of the Academic Institution signs and returns a copy of this Agreement, complete with full contact information for designated Administrative and Technical Contacts to Excelsior at the address indicated above.

LICENSE GRANT

Excelsior hereby grants to you a non-exclusive, non-transferable limited site license to use the accompanying Software for teaching and non-commercial research only on the following terms:

You may: **a.** install the Software on an unlimited number of computer systems owned, leased, or otherwise directly controlled by the Academic Institution, that are part of the Academic Institution's internal network domain, and located at the Academic Institution's permanent facilities; **b.** install the software on portable computers used by the Academic Institution staff when travelling on Academic Institution business; **c.** copy the Software for backup purposes, provided any copy must contain all of the original Software's proprietary notices.

You may not: **a.** use the Software for any non-teaching activity which is a work for hire or performed under contract to conduct proprietary research or create proprietary work product for the government agencies or the private, commercial enterprises; **b.** redistribute the Software or any portion of the Software without Excelsior's prior written consent; **c.** provide the Software for use by anyone except professors, teachers, instructors, students, administrators, and other personnel employed by, enrolled in, or volunteering at the licensed Academic Institution; **d.** provide the Software for use by anyone after their relationship with the Academic Institution ends; **e.** modify, translate, reverse engineer, decompile, disassemble (except to the extent applicable laws specifically prohibit such restriction), or create derivative works based on the Software; **f.** copy the Software (except for back-up purposes); **g.** rent, lease, or otherwise transfer rights to the Software; or **h.** remove any proprietary notices or labels on the Software.

"AT HOME" USAGE

In addition to the license granted above, professors, teachers, instructors, students, administrators, and other personnel employed by, enrolled in, or volunteering at the licensed Academic Institution are hereby explicitly granted the license to install and use the Software at their residences on any personally owned computers in support of their licensed uses at the Academic Institution, provided that: **a.** they agree to each provision of this Agreement; and **b.** the computers on which the Software is installed are part of the Academic Institution's

internal network domain. This personal residence usage license shall terminate if the relationship with the Academic Institution ends. "At home" usage may be subject to authentication by a licensing server and may require an active network link.

ACKNOWLEDGEMENT AND PUBLICITY

Any publication or presentation to which use of the Software under this Agreement materially contributed shall either describe the contribution made by use of the Software or note that the research was supported, in part, by a grant from Excelsior, LLC.

The Academic Institution grants to Excelsior the right to include its name in the list of academic users of the Software, published on Excelsior's corporate Web site and in marketing materials associated with the Software.

TITLE

Title, ownership rights, and intellectual property rights in and to the Software, and any copies of the Software shall at all times remain with Excelsior and/or its suppliers. The Software is protected by the copyright laws of the Russian Federation and international copyright treaties.

LABELS AND WATERMARKS

The copy of the Software furnished to you by Excelsior under this Agreement may contain labels and "watermarks" uniquely identifying that copy, and may include such labels and watermarks in its output. It is illegal to remove any such labels or watermarks or to disable the routines responsible for reproduction of such labels and watermarks in the output created by the Software.

TECHNICAL SUPPORT

You agree to designate one person from the Academic Institution to be the sole point of contact for all technical issues, including, but not limited to, support questions and access to product updates and fixes (Technical Contact). During the term of the Support Service, Excelsior shall provide that individual with the same level of technical support as a commercial user with active Standard Support Contract would receive.

Excelsior shall not respond to technical support requests from any other user of the Software within the Academic Institution, unless it

has been routed through the Technical Contact.

PRODUCT MAINTENANCE

Excelsior shall provide you with new versions of the Software released during the term of the Maintenance Service at no additional cost, if delivered via electronic download.

NO FAIL-SAFE USES

Failure to provide such contacts, even if they have not changed, shall be a breach of this Agreement.

The term of the provision of the associated Support and Maintenance Services shall be one year from the date of Excelsior's signature to this Agreement. These Services may then be renewed for a fee.

You may terminate this license at any time by destroying all copies of the Software you received or made under this Agreement. This Agreement shall terminate automatically if you fail to comply with any of its terms and conditions. On such termination, you must destroy all copies of the Software you received or made under this Agreement. The Disclaimer of Warranty and Limitation of Liability sections above shall survive termination of this Agreement.
